Yet Florida's death rate is no worse than the national average, and better than that of some other states that imposed more restrictions, despite its large numbers of retirees, young partyers and tourists. Caseloads and hospitalizations across most of the state are down. The tens of thousands of people who died were in some ways the result of an unspoken grand bargain — the price paid for keeping as many people as possible employed, educated and, some Floridians would argue, sane.

Oh look at both the admission **and the lie.**

Florida's death rate ***is no worse than the national average*** despite having an **older** population than, say, California and New York.

Governor DeSantis *banned* mask mandates and similar in **September** and, was told by all the clucking people, ***he was sentencing people to death who should not have to die.*** The other states including Tennessee, where I live, **allowed mandates to stand**, including the piece of crap mayor I have in *this* county, who kept his.

I pointed out **at the time** that the mask mandates *did not work, on the data and would not work.* I appeared **three times in sequence** to so-document at the County Commission meetings. *At the time of the last appearance there were 31 dead people in our county of 100,000.*

As of now that total stands at 166 -- despite the mandate.

Nearby Blount County, *literally next door*, has this for their infection curve:



Blount never had a mandate. Who "won"?

I was right, in short and have been on this point *since the entire mess started back in April*. You cannot prevent a virus from virusing *once it gets into wide circulation*. Lockdowns, unless they are **total** and involve *literally locking people into their homes and shooting or arresting anyone who does not do so* cannot stop the spread. The reason is simple: ***Most of the spread happens in households and the next most-likely place is in health care settings*** which we did nothing to interdict because masks and such *are statistically worthless*. **WE REFUSED, DELIBERATELY, TO QUARANTINE ALL HEALTH CARE WORKERS AWAY FROM THE GENERAL POPULATION AND THUS ATTEMPT TO PREVENT THEM FROM GETTING INFECTED.**

This is *stupid* and we knew that decades ago; *the policy for tuberculosis was to establish sanitariums and the people who worked in them had already suffered the disease and recovered*. We ***did not*** attempt to mingle tuberculosis patients with the general population of people who required health care for non-infectious reasons. *In several states with Covid-19 we did worse than just mingle people* ***we intentionally inoculated vulnerable seniors by sending sick people into their nursing homes under governor orders***. That's ***manslaughter*** and yet not ***one*** of the evil ********s*** who did it has been arrested.

The CDC ***itself*** (<https://www.cdc.gov/mmwr/volumes/70/wr/pdfs/mm7010e3-H.pdf>)

has now stated quite clearly that mask mandates ***are statistically worthless***; they are good for ***roughly a 2% reduction in Covid-19 death rates***. Note that their ***inside*** statistical claim ("worst case") was *less than 1% for both cases and deaths*. Worse, closing restaurants was only good for a ***2.2 percent***, at the outside, reduction cases and the inside, that is, least case rate reduction from closing restaurants for inside dining, was literally ***zero***.

Statistically speaking without the mask mandate the CDC *admits* that only between one and four additional persons would have died in Sevier County. *How many additional people committed suicide, ODD on drugs or drank themselves to death over the last year above last year's rate as a result of the mandate? Can I hang the Mayor if the number of the latter exceeds four?* Last time I checked *dead is dead* and why does not matter; the claim that the mandates "saved lives on balance" *is admitted by the CDC itself in its own document to be a bald-faced lie*.

How many suicides and drug ODs *nationally* were caused by the employment and social interaction destruction via these mandates? How many people *did not* go to the doctor for a lump, an odd neurological symptom or a pain in the chest *and now are dead from cancer, a heart attack or stroke* as a direct consequence of being scared into believing that ***any contact with others will kill them***? What makes you believe *that* excess death is over? *It most-certainly is not!*

We can only account for about half of the excess death in the last year via Covid-19, assuming you believe that Covid-19 claimed "deaths" were really caused by Covid-19 while there was no flu-related death at all.

Let's just take *one* statistical increase -- death by overdose. At 3% -- the *outside boundary* for mask "benefit" masks saved 15,000 lives in America (out of the 500,000 allegedly lost to Covid-19), assuming you believe every Covid-19 death counted is really from Covid-19. The run rate of death from ODs at the start of the Covid-craze was approximately 70,000/year. ***As of July, the latest date for which data is available*** (<https://www.cdc.gov/nchs/nvss/vsrr/drug-overdose-data.htm>) ***at present the OD expected 12-month count (remember, this is only about five months of time!) stood at 83,544.***

Are you sitting down? Good.

There was no net benefit whatsoever to the mask mandates counting just ODs and in fact there were materially more OD deaths caused on an annualized basis than there were lives saved from masks.

Alcohol abuse, cancers, heart attacks, strokes and similar also count *and show up in all-cause mortality; as noted only half of that increase can reasonably be attributed to Covid-19.* If the restaurant shutdowns and masks were only good for a 0-3% reduction in outcomes ***then the deaths that resulted from the policy responses and mandates were much worse than the "benefits" gained in the form of fewer Covid-19 deaths.***

Note that their "study" is crap; I could tear it apart *but for the purpose of this I will give the CDC the benefit of accepting "as plead, is true" the assertions they make.* In other words **I will not even bother ripping apart their alleged "study" because even if I accept it without question the data still says they're murderous *****s and their interventions had a net effect of killing people instead of saving them!**

Let me be clear: The CDC has admitted in print that for every death avoided through closing restaurants and bars, along with mask mandates five to ten deaths were *caused* in the form of excess suicides, drug ODs, alcohol abuse, cancers, strokes and heart attacks, none of which had anything to do with Covid-19 infection but all of which were a function of social, financial and economic stress *their demanded mandates deliberately imposed on the population.*

IN OTHER WORDS THE CDC ADMITTED IN PRINT THAT THEIR BULL** "MANDATES" AND "RECOMENDATIONS" KILLED FIVE TO TEN TIMES MORE PEOPLE THAN IT ALLEGEDLY "SAVED."**

Yet these bastards have not, *after admitting in print that their demanded mandates in fact caused five to ten times as much death as was avoided,* reversed course and demanded a rescission of all such "rules" and regulations *nor have the people of the nation apparently been able to perform basic arithmetic and then started erecting gallows on the lawn of every single government agency that has refused to stop killing the people within their jurisdiction at a greatly increased rate through their mandates.*

The problem with all of these NPIs (non-pharmaceutical interventions) as now documented by the government itself is that they were actually **worse** than useless, which incidentally the NY Times has now joined in admitting. Beyond the *directly* caused deaths from suicides and ODs **it has also allowed people to believe we were "doing something" that would slow the virus and give us time to develop vaccines while imposing more excess death from other causes than it saves from Covid-19 by a factor of five to ten times.**

The proof is now in that even the claim of "we'll buy time" was a lie. Not a **single** bit of evidence exists that the virus actually was attenuated by the vaccines; ***we reached the top of the curve and had started to decline before a single person had been fully vaccinated and had opportunity to build antibodies to the virus.*** In our county the peak 7 day rate was on 12/22; [here's the announcement on the first batch of those eligible in our county.](#)

The harms haven't ended with direct death through various maladies of despair either: **It was also a deliberate lie used as an excuse to prevent the exploration and use of existing drugs that were extremely unlikely to harm and might work, a policy that still continues today.**

Over 400,000 Americans are **dead** as a direct and proximate result of all of this and yet here we are with the NY Times **admitting** in print what I've said all along: **None of the so-called "mitigations" and measures, whether they be mask mandates, business closures, school shutdowns or similar saved a single net person-**

year of life; in point of fact the data is that none of them did a damned thing except kill multiples of those "saved" by causing more suicides, drug ODs, heart attacks and similar, destroyed a year's worth of our children's education which will cost trillions of dollars alone in lost productivity over the next fifty years and statistically-speaking the same number of people died of the virus that would have died anyway.

Every single one of the rat bastards in government and so-called "public health" deserves to be tried and executed for their intentional destruction of human life and dignity *for political and financial profit*. They knew damn well *on the data* that their policies did not and would not work *in the summer and early fall* and continued them anyway. Worse, we had *decades* of experience and hard science proving that they wouldn't work before Covid-19 ever appeared, much of which I've cataloged on my pages.

Willful blindness, particularly when someone comes before your government body and three times sequentially presents the facts before you in a public hearing cannot be used as an excuse.

(<https://wonder.cdc.gov/vaers.html>) There are **fifty-eight times** (5,800%) the number of associated deaths from Covid-19 vaccines *as last year's entire seasonal flu shot regime* (1394 .vs. 24.) Read that again: **FIFTY EIGHT TIMES** as many closely-associated deaths exist for Covid-19 shots which have only been given for the last three months *as for the entire period from last August to today on all the flu shot variations combined.*

The CDC has the audacity, *given this data*, to claim there are [no patterns in the cause of death that indicate a safety problem](https://www.cdc.gov/coronavirus/2019-ncov/vaccines/safety/safety-of-vaccines.html#:~:text=COVID%2D19%20vaccines%20are%20safe,soon%20as%20you%20are%20eligible.) Again, just in case you're *really* *****ing stupid and didn't read the last two paragraphs: We give flu shots to, largely, older and sicker Americans each and every year. *The entire last year's flu vaccination program*, which was **strongly** urged given the Covid-19 outbreak, was associated with 24 deaths. **Fifty-eight times that number of deaths have been associated with Covid-19 vaccine administration thus far yet it is claimed by the CDC that is "not indicating a safety problem."**

Oh, and as for my record those of you who followed me since the start of this crap in early 2020 know that *I was raising Hell that on the evidence this virus was expressed via feces in competent (infectious) form*. This was evident when an outbreak occurred early on *that had no other reasonable explanation than fecal transmission through drain pipes that had no P-traps* and that the virus continued to spread *in the summer*, which implicates some method spread *other than* droplet-based -- fecal, aerosol or *both*. This requires confirmation, of course, but if true it turns the entire load of garbage spewed by all the "authorities" on its ear.

It *entirely* explains why antibiotics work **which for viruses should be worthless, yet clearly on the evidence they are not**. Don't expect the CDC or NIH to run that down any time soon and, incidentally, that has wild implications for the below and what I believe on the evidence is likely to come -- and not in a good way either.

If this turns out to be factual *the virus will evade the vaccines* and our use of non-bioidentical vaccination will prove to be not only a failure *but a wildly dangerous failure*.

Since I'm taking a victory lap here in that I was right a year ago in that **none** of the lockdowns, mask orders, business and school closures would have a net positive impact **and unlike damn near everyone else I have not changed my position on the usefulness of such measures** I'll go out on a limb and point out that *I'm also not going to change my position on what I believe is likely to come next and this time you damn well better pray to whoever you worship that I wind up being wrong. We may well have pulled a "black ball" from the bag* by allowing this **bull****** to be run on us as a society instead of putting an immediate stop to it.

Simply put when you place *imperfectly matched* evolutionary pressure on a pathological agent *you risk horrifyingly bad results*. That's what we've learned over time. This is why we have MRSA and multi-drug resistant tuberculosis. It is why we have C.Diff. It is why in animal husbandry **we have potentiated horrifyingly bad infectious diseases** in factory farming and thus instead of killing 5 or 10% of an infected group of animals **we now must cull them all because they will all die; an effective 100% kill rate**, as a direct and proximate outcome from placing *imperfect immune pressure on said diseases rather than letting natural immunity be the source of protection*.

We are doing the same **ted thing now with Covid-19 and these "vaccines"** along with trying to prevent young and healthy people from getting the infection *naturally* and if we get **what we deserve** those who were **stupid** enough to take the shot are likely to get pounded with the "new and exciting strains" in the months and years ahead **and die as a direct consequence while quite-possibly killing their neighbors at the same time**.

Maybe that won't happen -- and we'll get lucky this time.

But if it **does** happen then there will not be a *damned thing* you can do about it **if** you took the jab. And no, it is **not** possible to out-vaccinate viral mutation; the typical viral "turn time" during which a mutation can take place is around 10 hours and the infectious generation time for Covid-19 approximately four to five days. *How long does it take you to recognize, reformate and re-jab everyone again?
